CLEAN ENERGY AND CLIMATE CHANGE: MCEA'S CLIMATE TEAM STRIVES TO ACHIEVE EQUITABLE, ECONOMY-WIDE GHG REDUCTIONS THAT WILL EXCEED BOTH THE AMOUNT AND TIMELINES IN MINNESOTA'S NEXT GENERATION ENERGY ACT, WHILE ENCOURAGING EQUITABLE COMMUNITY AND INSTITUTIONAL RESILIENCE TO ADAPT TO UNAVOIDABLE CLIMATE CHANGE.
